Notes from the May 30 LCC Board Meeting (official minutes are posted on website after board approval)

Minutes from the April 3rd and April 22 board meetings were approved.

A motion was made and approved by a majority of the board to reorganize officers, with Ann Larson replacing Dani Clark as President.

Several community comments were submitted, including concerns about transparency at the May 22 planning session, a request for a new park potty, and frustrations with moss compliance enforcement. Concerns were also raised about the nature and wording of the warning letters received by residents.

Several board members met in person for a planning session on May 22, where they discussed board efficiency and organization. Board Vice President Evan Clifthorne encourages all community members to attend these future planning sessions, which will be open to the community.

Residents William Murray and Mike Frank are graciously volunteering to build new boat racks this summer. Thank you! The Clerk reported some ongoing issues with the gates, specifically the main gate (Camden Pk) at the Main Rec. The deployment dates of new id (non-rfid) bands are listed below.

Questions surfaced about the possibility of new sand at the community beaches and new bark to cover the exposed cloth at the Tot Lot.

The Compliance Committee reviewed the process of VIS bringing violations to the Ken Lake Compliance Committee for review. They stated that the number of violations are

decreasing, and that the new rules, if adopted, will go into effect August 8th. You still have time to send in your comments.

The ACC had three approvals: a fence at 1814 Cedarbury, a deck at 2075 Lakemoor, and a dock extension at 1521 Lakemoor Loop.

The Events Committee reported that they will meet in June (tbd) to discuss the several upcoming events (summer social, yard sale, dog days of summer, yoga, & music in the park). In addition, Chairperson Maggie Marchand wanted to thank the following: Special recognition and thanks to Dan Renfroe for coordinating and running the Bike Safety Clinic on May 11th and also to community member volunteers Johanna and the Olympia Police Department.

The Lake/Stormwater committee stated that our new lake weed treatment company will come June 7th to assess and/or treat the current lake situation. Al Hatten reported that the water is currently 64 degrees, and at a normal level. He will start collecting water samples on June 10th. He also reported that the bass and bluegills have finished spawning!

The Urban Forest Committee did not meet this month. Co-chairperson Marian Bailey asked about her trail camera that was stolen from the UF trail, and the committee and board agreed on reimbursement for it.

There is still one hugel bed available in the Community Garden. See the front page for rental information!

The attorney retained by the LCC board had asked for clarification on who will speak for the board. A motion was made and approved by a majority of the board to designate the board vice president and president to serve as the board's legal liaisons.

Treasurer Leslie Turner discussed seeking a new insurance company to work with the community. With VIS's help, they will seek new bids.

An ad-hoc committee was formed to review existing contracts regarding responsibilities, deliverables & compensation, including the Clerk, Security, Park Manager, and the Management Company. The committee will be chaired by Dani Clark, who will be joined by Wendy Harris and Evan Clifthorne.

The board followed up on a community survey, conducted in the fall of 2023, about purchasing the vacant lot located at 2151 Lakemoor for the purpose of providing access to the City of Olympia's "Kaiser Woods Bike Park". The board approved the formation of an ad hoc committee to engage in a discovery process about all factors that may be relevant to a potential purchase, with a deadline to provide a report to the full board within 60 days. This is only an initial discovery process, and there will be significant additional opportunity for community comments. The committee will be chaired by John Ulmer, who will be joined by Wendy Harris and Evan Clifthorne.

On April 22, the LCC Compliance Committee presented suggested changes to the LCC rules to the Board of Directors. The board voted to send these suggested changes to the community for a 60-day comment period. Comments will be accepted via email to kenlakesecretary@gmail.com until June 22. Please note that the board has not made a determination on these changes. Any changes to the LCC Rules will be voted upon after receipt of community input. New LCC Wristband Distribution

June 2024

By accepting the new red, white & blue wristbands and/or the Radio-Frequency Identification (RFID) keyed red wristbands, the property owner understands and agrees to the following conditions and the Lakemoor Community Club (LCC) common area rules:

- 1. Standard (red, white & blue) wristbands: Each property owner will be issued eight (8) wristbands free of charge. Replacement of broken or damaged wristbands are free of charge with the return of the original wristband.
- 2. RFID (red) wristbands: Each property owner will be issued a maximum of only two (2) wristbands free of charge. These wristbands unlock gates at the Main Rec, Basketball/Tennis Courts at Sports Park, and Westside Park. Additional wristbands may not be purchased. Replacement of lost or stolen RFID wristbands can be purchased for \$25 each (checks only or added to your account) and will not be issued until the missing wristbands are deactivated. Residents are required to bring the remaining RFID wristband for reprogramming before a second one is issued. Replacement of broken or damaged wristbands are free of charge with the return of the original wristband.
- 3. All new or replacement wristbands will be issued upon appointment only via email to the LCC Corporate Clerk at kenlakesecretary@gmail.com. Written wristband requests may take up to two (2) weeks to fulfill.
- 4. Both standard (red, white & blue) and RFID (red) wristbands are coded and assigned to individual property owners/address on the property title. Renters may obtain wristbands from their landlords.
- 5. Both standard (red, white & blue) and RFID (red) wristbands are waterproof and made to be worn while swimming.
- 6. Owners not current with their quarterly LCC assessments may lose their common area privileges.
- 7. Wristbands must be worn by all owners/residents and owner/resident guests when visiting LCC common areas. They shall be shown upon request to security and/or other residents. If the person visiting a common area cannot produce a valid wristband with matching credentials, they will be asked to leave the common area even if they are residents.
- 8. Common areas are private property and not open to non-residents unless accompanied by an LCC owner/resident. An LCC owner/resident must be present and wearing a wristband when guests are using a common area.

9. Large Gatherings: If you are planning a gathering of more than 10 people, a free permit must be obtained through the LCC Corporate Clerk. The LCC owner/resident that obtained the permit is required to wear a wristband, but attending guests will not need wristbands. An adult LCC owner/resident must be present with guests for the entire party. The Clerk will only reserve one party at the same time/same place. The permit is not exclusive, so you will share the park with other residents. Owners/residents must follow all Common Area rules, in addition to the "pack in, pack out" rule listed on the party permit application. Violators will lose their park reservation privileges.

COMMON AREAS RULES

As Approved by LCC Board, October 2020

- 1. Use of all common areas is restricted to LCC members in good standing and their guests. Members in good standing shall not be delinquent in assessments.
- 2. Guests must be accompanied by a resident. Exceptions may be granted by contacting the LCC Corporate Clerk.
- 3. Park users must wear LCC-provided identification while present in any of the common areas or they will be asked to leave the common areas.
- 4. Non-RFID LCC-approved identification may be provided by residents to guests during LCC visits and shall be returned to the resident at the end of each visit. LCC-approved identification may not be provided to non-household guests.
- 5. LCC RFID wristbands may only be used by residents. Providing LCC RFID wristbands to non-residents is not allowed.
- 6. Any LCC member or guest who exhibits abusive or disrespectful behavior, disregards common area rules, or engages in the destruction of common area property may be subject to disciplinary actions to be determined by the board.
- 7. No pushing, running, or rough housing on the floats, docks or beach areas. No vulgar or inappropriate language will be tolerated in any common area.
- 8. Football, soccer, baseball, or other sports are allowed in the Sports Park and Tot Lot only, unless as authorized by the LCC board for a community-sponsored event.
- 9. The enclosed swimming area at Main Rec Area is primarily intended for use by young swimmers and their guardians. No kayaks, canoes, boats, or stand-up paddleboards shall be allowed in the enclosed swimming area.
- 10. No dogs are allowed in any of the common areas except the designated Dog Park near the Sports Park and in the Urban Forest on a leash. This rule does not apply to registered service animals. Such service animals must be on leash and in the immediate control of the owner.
- 11. No motorized vehicles or bicycles shall be ridden on the grassy areas of any of the common areas.
- 12. Each resident is responsible for cleaning up after use of the common areas.
- 13. No open fires.
- 14. No smoking or vaping is allowed in any of the common areas.
- 15. No glass objects shall be allowed on the beach areas, docks, or floats.
- 16. Climbing of fences in common areas is not permitted.

17. Electronic audio equipment shall be limited to a volume where no park users or residents object.

Exceptions are LCC board sanctioned events.

- 18. Common areas shall be available for use from dawn until dusk.
- 19. Drones and other radio-controlled aircraft are not allowed over common areas or the lake.
- 20. The carrying of weapons within the common areas is prohibited.
- 21. Groups of more than 10 in any common area must be approved by and reserved in advance with the

LCC Corporate Clerk.

Ken Lake shoreline will be treated TWO times with aquatic herbicide between May 28, 2024, and August 31, 2024. All days/weeks WILL NOT incur treatment. Shoreline Notifications will be posted on the day(s) of treatment.

POTENTIAL PRODUCT(S) PLANNED FOR USE: Fluridone, Tribune, Aquathol K, Imazapyr, 24D, Glyphosate, Flumigard

ACTIVE INGREDIENT(S): Fluridone, Diquat Dibromide, Dipotassium Salt of Endothall, Isopropylamine salt of Imazapyr, Dimethylanine Salt of 2, 4-Dichlorophenoxyacetic Acid, Glyphosate, Flumioxazin

PLANTS/ALGAE TARGETED: Nuisance and noxious submerged vegetation.

LOCATION OF TREATMENT(S): Ken Lake shoreline

The applicator will post signs in the treated and potentially affected areas no more than 48 hours prior to treatment. The signs will describe any water use restrictions or advisories.

If you are withdrawing water for potable or domestic water use, livestock watering, or irrigation, and have no alternate water source, please contact Northwest Aquatic MANAGEMENT at info@nwaqua.com to arrange an alternate water supply.
